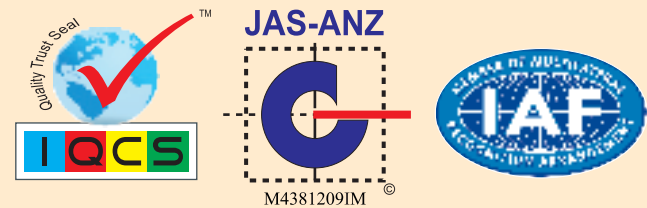

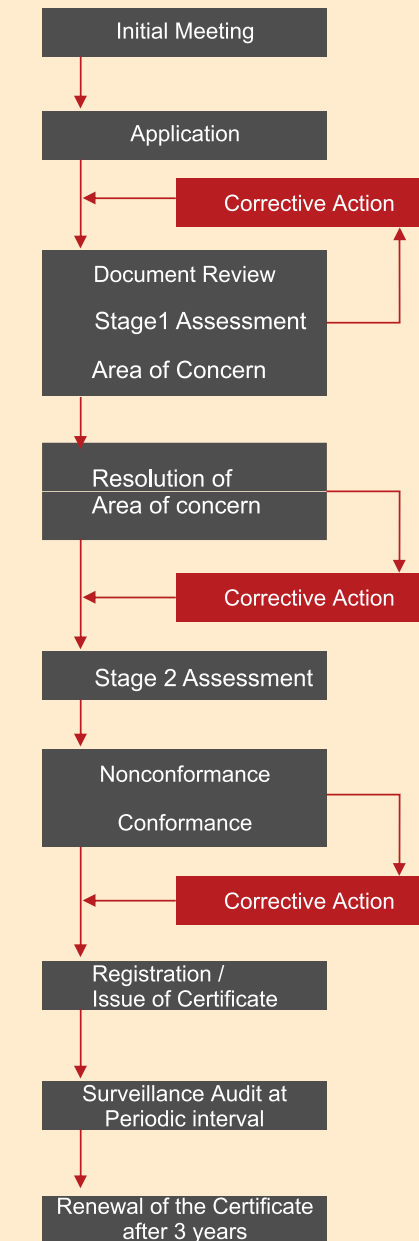

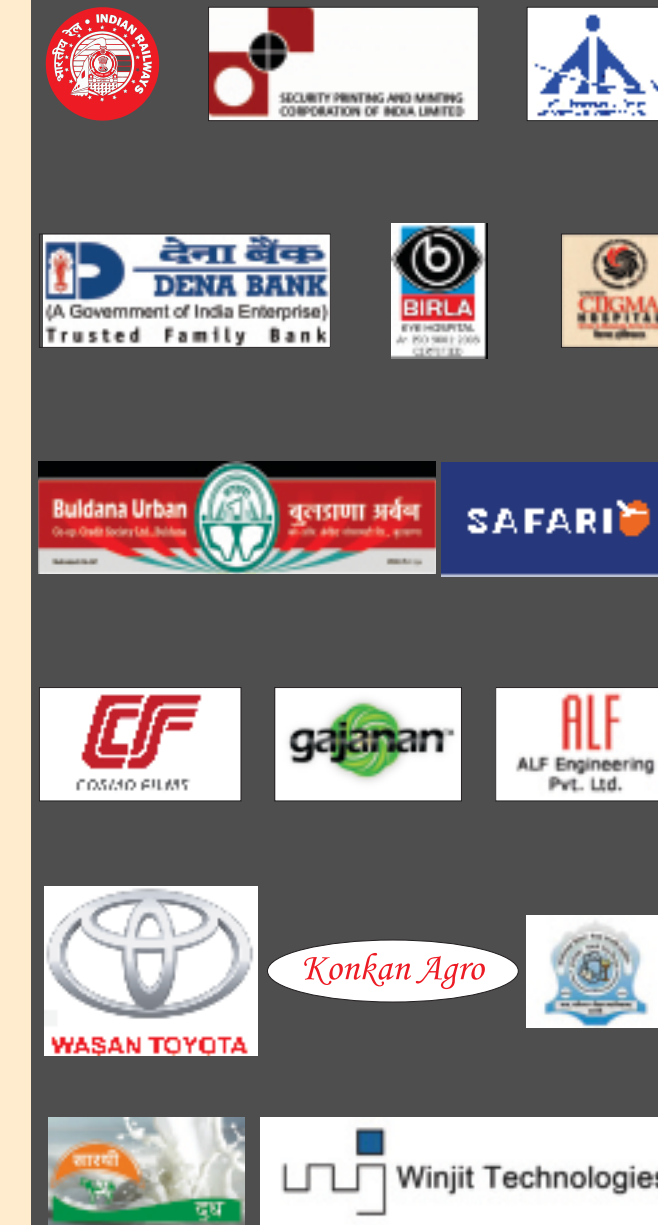

OHSAS 18001 is an assessment specification for Occupational Health and Safety Management System.

It enables organization to manage operational risk and improve performance. It also provides guidance on how to manage the health and safety aspects of business activities more effectively, while taking into careful considerations accident prevention, risk reduction and the well-being of employees.



ENERGY MANAGEMENT SYSTEM (ISO 50001:2011)

ISO 50001:2011, Energy management systems – Requirements with guidance for use, is a voluntary International Standard developed by ISO (International Organization for Standardization). ISO 50001 gives organizations the requirements for energy management systems (EnMS). ISO 50001 provides benefits for organizations large and small, in both public and private sectors, in manufacturing and services, in all regions of the world. ISO 50001 will establish a framework for industrial plants ; commercial, institutional, and governmental facilities ; and entire organizations to manage energy. Targeting broad applicability across national economic sectors, it is estimated that the standard could influence up to 60% of the world's energy use.



INFORMATION SECURITY MANAGEMENT SYSTEM (ISO 27001:2013)

- ▶ Part of the overall management system, based on a business risk approach, to establish, implement, operate, monitor, review, maintain and improve information security (ISO definition)
- ▶ Influenced by the organization's needs and objectives, security requirements, the processes employed and the size and structure of the organization.
- ▶ A holistic approach to managing information security – confidentiality, integrity, and availability of information and data.
- ▶ Expected to change over time.

Why is compliance with ISO/IEC 27001 important?

Compliance with these standards, confirmed by an accredited auditor, demonstrates that Microsoft uses internationally recognized processes and best practices to manage the infrastructure and organization that support and deliver its cloud services. The certificate validates that Microsoft has implemented the guidelines and general principles for initiating, implementing, maintaining, and improving the management of information security.



QUALITY SYSTEM – MEDICAL DEVICES ISO 13485 : 2003

ISO 13485:2003 specifies requirements for a quality management System where an Organization needs to demonstrate its ability to provide medical device and related service that consistently meet Customer Requirements and Regulatory requirements applicable to medical devices and related Service. The primary objective of ISO 13485:2003 is to facilitate harmonized medical device regulatory requirement for Quality Management System. As a result ,it includes some particular requirement for medical device and excludes some of the requirements. Because of these exclusions, organizations whose quality management system conform to this international standard cannot claim conformity to ISO 9001

All Requirements of ISO 13485:2003 are specific to organization provide medical device .regardless of the type or size of the organization.



CE MARKING :

CE making was introduced by the European Commission IN 1985 and it is the Commission who also set the conditions for use of the CE mark within the different CE mark directives. With the CE Marking, the manufacturer or his representative within the EU declare that the individual product is in compliance with the general safety regulation in the CE Marking directives.
